- 12. In case a member fails to pay the bills within the specified period, their names will be put up in the "Defaulters" list and will not be allowed to use the Club until the dues are cleared.
- 13. If a member delays payments then he/she is liable for paying a penalty of Rs.500/- per month. In case the dues are not cleared within a maximum period of 4 months, membership to the Club will be considered cancelled.
- 14. The Management shall be vested with sole discretion to revise the amount of annual subscription and any other charges, as and when deemed fit. Such terms shall be valid & binding on the members.
- 15. The annual subscription fee paid by a member shall entitle the member to use only those Club facilities as prescribed by the management from time to time and the management may require a member to pay additional fees for the use of any other additional facility as may be decided by the management from time to time.
- 16. Spouse and dependant children of members will also be entitled to use the facilities of the Club as mentioned above, but liabilities of expenses incurred will be that of the member.
- 17. Guests can be brought by members but they can avail the facilities of the Club only as per rules and regulations of the Club and with the permission of the management. The name of the guest and that of the member will be entered in the register kept at the reception. Guests of the members will be admitted only if accompanied by the member. The member will be held responsible for his guest's behaviour within the Club premises.
- 18. The member is required to follow proper etiquette including decent dress and good behaviour in order to maintain the decorum of the Club
- 19. If a member under resident category sells his property, he must inform the club manager. His membership would then stand as cancelled.
- 20. Every member will be liable to show his/her identity card on demand. The security guard reserves the authority to restrict entry to the Club, in case of non-production of the I-Card.

Rules & Regulations

1. The management of Veridian Club will be vested in the Board of Directors of the Club and such an executive may be appointed and authorized by the board for this purpose.
2. Every applicant for membership to the club shall not be less than 18 years of age. The club facilities may be used only by members/their spouses, dependant children and guests accompanied by members.
3. Every applicant for membership shall submit an application in the form prescribed by the club, complete in all respects, for consideration by the management.
4. While applying for membership, the applicant must clearly state whether he/she would require any dependant cards and the details thereof should be clearly specified in the space provided in the application form.
5. On reaching the age of 18 the dependant of a member, having previously used the club as a dependant, shall not be allowed to further use the Club as a dependant and his/her identity card must be returned to the club. The dependant can opt for new individual membership at the rates applicable at that point of time.
6. To avoid delay in scrutiny and/or acceptance of application, please ensure that application form is filled in completely and is accompanied by the requisite photographs, full payment as applicable and photocopy of all documents required.
7. Acceptance of the application form does not entitle a membership. The management reserves the right to admit or refuse admission to any candidate and enrollment, as membership is subject to selection by the club managing committee whose decision shall be final and binding.
8. In case an applicant is rejected, membership application money will be refunded without interest.
9. Non-Resident Indians are expected to send all payments in respect of their application drawn only from their non-resident external/non-resident ordinary account or by Bank Draft in Indian Rupees drawn from their account abroad.
(N.B. Payment of bills in case of non-resident Indians is also subject to this stipulation).
10. The requisite application amount will be paid by local banker's cheque/bank draft drawn in favour of the 'Veridian Club.'
11. The membership to the Club will cease at the end of each financial year. Membership shall not be deemed to have been renewed automatically. Membership will be renewed annually only if he/she pays his annual subscription charges for next financial year & fulfills the other terms and conditions of such renewal.
